Dear Siblings in Christ,

We enter this month of February with a big step forward in the Trinity UMC process of disaffiliating from the United Methodist Church.

It was on Sunday, January 29, 2023, that the disaffiliation vote took place at Lomira Trinity UMC, led by DS Park Hunter. Two members of the Wisconsin Conference Disaffiliation Team were present: Rev. Eliud Martinez from Fond du Lac Salem UMC and Rev. Diane Rew from Green Bay St. Paul's UMC.

With 94 professing members voting, Lomira Trinity UMC had a 95% vote in favor of Disaffiliation from the UMC. 89 member voted for disaffiliating from the UMC and 5 members against. Our professing membership list has 235 names on it. So, why am I starting this article giving this information while we have a Trinity disaffiliation taskforce which is supposed to do it?

It's because times like this are not easy to handle by church members and even by pastors because they can easily affect the relationships among them.

The truth is we had people who voted for and others against disaffiliating from the United Methodist Church, and others did not even vote we don't know why. So, how can we discern times like this while transitioning as we are expecting a change at Trinity UMC? As your Pastor, I give the advice below:

Prayer

It should go without saying that pastors should be praying. In fact, that should go without saying for anyone who is a Christian. We even learned in Sunday School as kids in a song. I am writing it in French then I will try give you the meaning in English,

"Lis ta Bible, prie chaque jour, prie chaque, prie chaque jour, lis ta Bible, prie chaque jour si tu veux grandir..." https://www.youtube.com/watch?v=f9VBKIgm8Hs

This little song means in English, "Read your Bible and pray every day if you want to grow." Remember growth is a part of our vision statement at Trinity UMC. How many of us really take the time to pray through everything? A prayer and submitting to the Lord's direction are highly needed in time like this.

Relying on the Holy Spirit

Too often, we rely on our own intelligence, wisdom, commitment, self-confidence, self-esteem in all our accomplishments. We try to admire the cover of our books but not the contents in them. The Holy Spirit, however, calls us away from that. He makes us fully dependent on God. He gives us the exact mind of Christ, which brings discernment into situations that we could not gain on our own. Not only that, but the Holy Spirit also gives us the power to act as Jesus would. Without the Holy Spirit's activity in our life, and our submission to His activity, we can't go anywhere.

The truth is Trinity United Methodist Church will be a subject to many changes but remember that God, Jesus, and the Holy Spirit will remain the same. And the word of God will remain the same. What will continue to keep us united as brothers and sisters in Christ is the Word of God found in the Holy Bible. Change involves more than the eye can perceive at first glance. Change is moving to something different and within each change, one or more transitions are continually taking place. A new way of being, a new way of experiencing life, a new way of handling what comes next...

As we are transitioning from one point to another one, we need to allow the Holy Spirit to help us in our work to view the changes in our lives, our families, our communities, in our worship, in our church, and in the world, as new ways of being.

From my own experience, I would like to finish by sharing with you that none of the above advice will keep us from experiencing difficulty. We are still human, and although we have been set free from the power of sin and have been given the Holy Spirit, there will be times we will make mistakes. When we deal with other humans there will be difficulty,

misunderstanding, hurt feelings, anger, bitterness, resentment, etc. It is my hope that whenever this happens, remembering the advice given above will help us navigate through that. All we need is to demonstrate humility and listen for what God is saying to us in those times, and then applying what He is saying and leading us to do.

So, February is the month leading us into the season of Lent, a time to focus on our relationships with God and others in a disciplined way. Too easily we become distracted or burdened by the demands laid upon our shoulders by our jobs, our families, other people, and other circumstances. We need to remember that this year, on top of our routines and daily burdens, Trinity UMC has task to accomplish the disaffiliation process all of its implications that can affect our relationship with God and with each other.

Disaffiliation from the United Methodist Church

Questions! Questions! We have so many questions!

On January 29th, we crossed one big hurdle in the disaffiliation process. 94 professing members of Trinity Church voted with 95% voting to proceed with disaffiliation from the United Methodist Church. We know that this has been a difficult conversation for our church family, with tensions high at times, and friendships tested. Please continue to pray for each other for healing and discernment as we move forward.

Our next questions for us to discuss are:
What is our future mission and vision for our church?
What denomination do we want to align with?
What will our new church name be?
How will we pay for the disaffiliation fees?

The Disaffiliation Task Force will be meeting this week, Feb 1, and the Administrative Council will also meet next week, Feb. 8. We will start the discussion of these issues, and develop a plan to guide our congregation in making these decisions. Please join us for a **congregational meeting after our worship service on February 12**th to give your input. Please also put some thought into the above questions before Sunday, February 12th.

We will have copies of articles to read to help you digest the information. One of these articles is available on-line now, if you want to get started:

<u>Considering Methodist Options - Good News Magazine</u>, an article written by Tom Lambrecht, found on the Good News Magazine website, dated 12-9-2022. It is comprehensive review of many aspects of a denomination: doctrine, trust clauses, bishops, clergy appointment, denomination financial support, denominational size and history. A chart comparing the various Methodist options is included in the article and is also included this newsletter. Paper copies of each will be available starting Feb. 12th.

We have heard from many people that they would like to retain "Trinity" in our new church name, because of its long history, and it's connection to the joining together of three churches. Think about what would make our name unique, or what would tell the community that we have changed the direction of our church? Trinity ______?

Regarding the disaffiliation fees, we were very pleased to learn that the amount we are expected to pay was lowered by about 30%, to \$165,000. It is not the final amount but we would not expect it to be much different, as long as the economy is in this slump! We have a commitment from Theresa State Bank to allow us to put this amount on our line of credit. We will be asking everyone in our church family to consider how they can sacrificially give in order to pay this off, even over and above what you are regularly giving to support the ministry of the church.

Please prayerfully consider all that is still before us. Please pray for your church leadership as they discern how to guide our church in the next year. Put thought into the questions mentioned above, and write down your own questions for our Feb. 12th meeting. Finally, please pray for Pastor Mulongo as he ministers to us and wrestles with us in these decisions.

STEWARDSHIP AND FINANCE OFFERING

It's been a while since I wrote you all last. Since we just finished the 2022 year, I thought I would get everyone up to date with where our church finished 2022 Financially. We took in \$7,569 in Christmas Offerings. Thank you so much for your gifts towards this. The SF team has decided again to take 10% of the Christmas Offerings and put the towards different ministries in the church. Overall, we finished the year with a \$23,771 deficit which was around \$3,700 more than last year. This means we were not able to fully give apportionments to the UMC again in 2022 as that total is \$39,996. For 2022 we averaged a weekly giving from 30 families of our possible 147 families in the church and we took in on average \$3,622 per week.

Some other update information: the replacement windows in the fellowship hall are on order and will be installed in Spring. These totaled \$3,500 in costs and the church has a \$1,000 insurance deductible to pay to replace those windows. Currently the balance of the A/C units is at \$32,672 as of the end of December.

As we are early in 2023 the SF committee wants you to think of your church each week and the needs we have. Think of how you can contribute, review your year-end statements and ladder chart when you receive them and determine how you can better serve the Lord through your tithes and offerings at Trinity. How can you improve on your current giving status. I want to leave you with a verse that I think reads as a mission statement of any church. How can we work together to accomplish this.

Teach those who are rich in this world not to be proud and not to trust in their money, which is so unreliable. Their trust should be in God, who richly gives us all we need for our enjoyment. Tell them to use their money to do good. They should be rich in good works and generous to those in need, always being ready to share with others. By doing this they will be storing up their treasure as a good foundation for the future so that they may experience true life. — 1 Timothy 6:17-19 NLT

Cemetery Lots

Cemetery lots are available in three area cemeteries that are coordinated through our church. These cemeteries were on the properties of churches that eventually closed and combined to form the current Trinity United Methodist Church.

- Salem Cemetery The corner of Highway 67 and Third Street. 1070 Church Street in the Village of Lomira.
- Ebenezer Cemetery The corner of County KK and Butternut Road. Northeast of Lomira in the Township of Lomira.
- Emanuel Cemetery Corner of County Y and County AY (Lomira Drive and County AY). West of Lomira in the Township of Lomira.
- Trinity Woods Memorial-Corner of Highway 67 and East Avenue. Behind the church

Trinity United Methodist Cemeteries Associated is the group that maintains the three cemeteries: Salem Cemetery, Ebenezer Cemetery And Emanuel Cemetery.

There is a Trustees Board composed of nine persons who care for the cemetery property and related business. There are multiple representatives for each cemetery.

Lots are available to all members and non-members at all cemeteries. Human remains only. Above ground monuments only. NO shrubs or trees are allowed on lots. To keep the cemetery clean, all flowers and memorials should be placed in vases or on top of the monument.

Deeds are presented with each lot after full payment.

One body burial and one cremated human remains will be allowed on a single lot. Or, two cremated human remains will be allowed on a single lot. Each burial must pay the perpetual care fee. Perpetual care fees are used to maintain all three cemeteries including lawn mowing, snow removal, and planting grass. Family members are responsible for stone maintenance.

You can reserve your lot in any of our three cemeteries now. You can reserve a lot for you and your family members. We have lots available in all three cemeteries and can accommodate multiple lots together.

The current rates effective June 1st 2023

Members: Lots: \$500

Perpetual Care: \$1000

Non Members: Lots: \$1,000

Perpetual Care: \$2,000

Trinity Wood Memorial ashes distribution \$100.00 per person with no marker plus engraving price for memorial plaque.

Each burial must pay the perpetual care fee. Perpetual care fees are used to maintain all three cemeteries.

To place an urn (cremated remains), please contact one of the committee members. Each urn requires perpetual care.

If a member of the Trinity United Methodist Cemeteries Associated digs and buries the urn, there is a \$100 fee per urn.

Contact the person for each cemetery or you may send an email to the Trinity United Methodist Church office. Please note the office is only staffed a few hours during the week.




